

CALIFORNIA SENATE BILL SB-577

WHAT IT MEANS FOR PATIENTS

California Senate Bill SB-577, which was signed by the governor in September 2002, has profound implications for the practice of alternative forms of health care in California. SB-577 enables alternative and complementary health care practitioners to provide and advertise their services legally. However, they must also comply with certain requirements specified within the bill.

What does Senate Bill SB-577 mean for you, the patient?

SB-577 gives you access to alternative and complementary health care practitioners. You must be given information about the nature of treatment and the practitioner's qualifications. Feel free to ask a practitioner any question you might have about your treatment. Check to see if your practitioner has been certified by a professional membership society. In addition, tell your doctor about any alternative treatment you are pursuing. You can also request that your licensed and unlicensed health care providers communicate with each other and work collaboratively to meet your health care needs.

SB-577 helps to protect you. SB-577 requires unlicensed alternative healthcare practitioners to follow certain guidelines and restrictions.

Here are the things that unlicensed alternative practitioners are NOT allowed to do:

- Perform any form of surgery or any procedure that punctures your skin or harmfully invades your body.
- Use X-ray radiation.
- Prescribe prescription drugs, or recommend that you discontinue drugs that were prescribed by a licensed physician.
- Set fractures.
- Treat wounds with electrotherapy.
- Put you at risk of great bodily harm, serious physical or mental illness, or death.
- Imply in any way that they are licensed physicians.

In addition, an unlicensed alternative practitioner MUST DO the following things:

- Provide you with a statement, written in plain language that includes the following information: (1) that they are not a licensed physician and that their services are not licensed by the state; (2) a brief and clear description of the kind of services they provide and the reasoning behind it; and (3) a description of their education, training, and experience.
- Ask you to sign and acknowledgement that you received the above written statement, and provide you with a copy of it. They must also keep a copy of your signed acknowledgement for three years.

ADDITIONAL INFORMATION

CLASSICAL HAHNEMANNIAN HOMEOPATHY

The principles on which Classical Hahnemannian Homeopathy is based are:

1. Vital Force – the life energy that animates every living being. Homeopathic treatment seeks to stimulate and balance this energy in order to improve health.
2. Susceptibility – a person’s resistance to disease. Homeopathic treatment aims to affect a person’s susceptibility in order to strengthen their resistance to disease.
3. Miasms – the homeopathic term to describe a person’s inherited predisposition to develop certain types of illness. Homeopathic treatment seeks to reduce the impact of these predispositions.
4. Proving – homeopathic drug testing. Healthy human volunteers take homeopathic remedies until they develop symptoms, which are carefully recorded. This information is used by homeopaths in order to select a remedy.
5. Potentization – the unique process by which homeopathic remedies are made. It is a carefully controlled process of repeated dilution and succussion (shaking).
6. Law of Similars – a homeopathic remedy which gives rise to a certain set of symptoms in a proving (see #4) is capable of relieving the same set of symptoms in a sick person. Homeopaths are trained to select the one remedy (out of over 2,500) that will most closely match the symptoms of the client.
7. Minimum Dose – homeopathic treatment gives the smallest possible amount of a remedy, just enough to stimulate the healing response of the Vital Force (see #1). Only one remedy is given at a time.
8. Direction of Cure – as healing proceeds, symptoms improve in a certain sequence:
 - symptoms move from above downwards
 - symptoms move from more vital organs to less vital ones
 - symptoms move from the inside of the body towards its surface
 - symptoms disappear in the reverse order of their appearance
9. Totality – the whole picture of a person’s symptoms: physical, mental and emotional. Classical Homeopathy always treats the totality.
